

LPN MOBILITY TRACK TO ASSOCIATE DEGREE NURSING CHECK LIST
 REVIEW BEFORE APPLYING

Only graduates of a state approved LPN Programs with a minimum grade of C or higher in EVERY course may apply to the Mobility Track. All applicants must be certified as a Licensed Practical Nurse. Applicants must have an active license (license may be in any state in the U.S.). Applicants must have equivalent of five months full time work experience as an LPN which will be verified by employer. The work experience must be completed before the first nursing courses Nursing 1160/1165, not by the date of submitted application. √

1. **Submit LPN Mobility application with \$20.00 application fee (unless you previously paid an application fee to Inver Hills community College)** ()
2. **Submit official copies of all previous transcripts (attach to application)** ()
 (Faxed transcripts are not accepted).
 It is not necessary to request an IHCC transcript.
3. **Take the assessment inventory in English, math and reading. (attach to application)** ()

NOTATIONS: College transcripts must reflect:

- Completion of a minimum of 10 college level credits. ()
- A cumulative GPA of 2.75 or greater. ()
- Completion of a 4 credit Chemistry or Biology Course with a lab, with a C or higher. (not A & P or Micro) ()

ASSESSMENT CLARIFICATION: College applicants are required to take the assessment inventory in English, Reading and math. **IMPORTANT:** All remedial/development coursework determined by assessments must be completed by the application deadline. Applicants must have completed Math 90 or assessed into a higher math level.

Applicants who have current assessments on file at Inver Hills (within two years) or have completed a college level English and math with a C or higher have met this requirement. Transfer applicants who have earned a C or higher in a college level English composition course and a college level math course are exempt from the English and math assessment for this program.

Students with a previous Bachelor's Degree from an English speaking country are exempt from the Reading Comprehension, and Writing English assessment. If previous transcripts reflect a college level math course (Inver Hills Math 1101/Century Math 1025 or higher) with a minimum grade of C these applicants are also exempt from the math assessment.

International applicants are required to take the English, Math & Reading assessment. Foreign transcripts must be evaluated by World Education Service (W.E.S.) info@wes.org or (212) 966-6311
